My involvement with the Corpus of Anglo-Saxon Stone Sculpture goes back to 1969, when I became the first research assistant attached to the project — first part time, then full time until 1978. My first thanks are therefore due to Professor Rosemary Cramp, the late Lord Fletcher, and the British Academy, for setting my feet on a path from which they have rarely strayed, though it has widened to include other pre-Conquest arts — especially manuscript illumination, metalwork, and latterly textiles.
